# Supreme Court barred unregulated soil extraction

**Context:** The Supreme Court reversed a three-year-old Environment Ministry notification exempting ordinary earth extraction for linear projects like road and railway construction from needing Environmental Clearance (EC).

#### Background:

- In March 2020, the Environment Ministry issued an exemption allowing extraction of ordinary earth for linear projects, like roads and pipelines, from requiring Environmental Clearance (EC).
- The exemption faced challenge before the National Green Tribunal (NGT), which directed the Ministry to review it within three months.
- As the Ministry delayed action, the matter reached the Supreme Court, which struck down the exemption on March 21, 2023, deeming it "blanket" and "arbitrary".

#### Nature of the Exemption:

- The 2020 notification added "Extraction or sourcing or borrowing of ordinary earth for linear projects such as roads, pipelines, etc" to the list of exempted activities.
- The Centre argued that the exemption was necessary for the aid of the general public and for various nonmining activities identified by states.

#### Supreme Court Verdict:

- The SC held that the "completely unguided and blanket exemption" was arbitrary and violated Article 14.
- It criticized the lack of defined safeguards and justifications for dispensing with public notice.
- Even subsequent notifications failed to address concerns regarding the concept of linear projects and environmental safeguards.

#### Past Judicial Scrutiny:

- January 2018: NGT overturned Ministry's 2016 exemption for construction projects over 20,000 sq m.
- July 2015: NGT struck down Ministry's 2012 and 2013 Office Memorandums granting ex-post facto EC.
- July 2021: Ministry extended amnesty window for projects categorized as violations; SC intervened in January next year.
- March 6: Kerala HC nullified 2014 exemption for educational and industrial structures exceeding 20,000 sq m.

#### **Environment Protection Act, 1986**

- The Act came into force on Nov. 19, 1986 and extends to the whole of India.
- The Act was passed to provide for the protection and improvement
   of environment and for matters connected there with.
- The Act gives certain powers to the Central Government to take measures for the purpose of protecting and improving the quality of the environment and to prevent environmental pollution.
- The Act is an "umbrella" legislation designed to provide a framework for Central Government coordination of the activities of various central and state authorities established under previous laws, such as the Water Act and the Air Act.

## Paradip Port tops Indian Major Ports in cargo handling

**Context:** Paradip Port Authority achieved a record-breaking cargo throughput of 145.38 MMT in FY 2023-24, surpassing Deendayal Port, Kandla.

#### Performance Highlights:

- Paradip Port Authority (PPA) achieved a recordbreaking cargo throughput of 145.38 MMT in FY 2023-24, surpassing Deendayal Port.
- Recorded a growth of 10.02 million metric tonnes (7.4%) of traffic on a Year-on-Year (YoY) basis.
- Achieved highest ever coastal shipping traffic of 59.19 million metric tonnes, with a growth of 1.30% over the previous year.
- Thermal coal coastal shipping reached 43.97 million metric tonnes, a 4.02% increase over the previous year.

#### Operational Improvements:

- Improved berth productivity to 33014 MT, registering 6.33% growth.
- Handled 21,665 numbers of rakes, a growth of 7.65% over the previous financial year.
- Handled 2710 ships, an increase of 13.82% over the previous financial year.

#### System Improvement Measures:

- Enhanced operation system at mechanized coal hand plant resulted in the highest handling of thermal coal at MCHP.
- Declaration of the northern dock for handling 16 meters draught cape vessels.
- Simultaneous handling of 1 Cape and 1 Panamax at coal handling berths.

#### Financial Results:

- Operating revenue crossed Rs. 2,300 Crores, exhibiting a 14.30% increase over the previous fiscal.
- Operating surplus crossed Rs. 1,510 Crores, showing a growth of 16.44%.
- Net surplus before tax crossed Rs. 1,570 Crores, with a growth of 21.26%.
- Net surplus after tax increased by 20% to Rs. 1,020 Crores.
- Operating ratio improved to 36% from 37% last year.

#### What is the Purchasing Managers' Index (PMI)?

- The PMI is an index that indicates the prevailing direction of economic trends in manufacturing and service sectors.
- It summarizes whether market conditions are expanding, staying the same, or contracting from the perspective of purchasing managers.
- The purpose of the PMI is to provide information about current and future business conditions to decision-makers, analysts, and investors.

#### Formula and Calculation of the PMI:

- PMI = (P1 \* 1) + (P2 \* 0.5) + (P3 \* 0)٠
- P1 represents the percentage of answers reporting an improvement, P2 represents no change, and P3 represents a deterioration.

#### How the PMI Works:

- It is a survey-based indicator compiled monthly by the ٠ Institute for Supply Management (ISM).
- The survey is sent to senior executives at over 400 companies in 19 primary industries, covering areas such as new orders, inventory levels, production, supplier deliveries, and employment.
- A PMI above 50 indicates expansion, under 50 indicates contraction, and at 50 indicates no change.

#### Using the PMI:

- Corporate managers use PMI results to make key decisions about their businesses, including production, inventory management, and staffing.
- Suppliers use the PMI to estimate future demand for their products, manage inventory, and determine pricing strategies.
- Investors leverage the PMI as a leading indicator of economic conditions to gain insights into developing trends in the overall economy.

#### **Global PMI:**

- The Global PMI is an economic indicator derived from questionnaires sent to manufacturing and services companies in over 40 countries.
- It gathers responses from approximately 28,000 global companies, representing 89% of global GDP.

#### **Interpreting a High PMI Reading:**

- The Purchasing Managers' Index ranges from 0 to . 100.
- A reading above 50 indicates economic expansion, with higher readings indicating greater growth.
- Readings below 50 signal economic contraction, with lower readings indicating more severe contraction.
- A reading of 50 signifies no change in the economic environment.

### PMI survev

Context: The latest March manufacturing Purchasing Managers' Index (PMI) survey indicates a significant surge, reaching its highest level in 16 years.

- India's manufacturing sector experienced a significant surge in March, with both new orders and output levels rising at the fastest pace since October 2020.
- Export orders also saw substantial growth, reaching the fastest pace since May 2022, while producers resumed job creation after a two-month pause.
- Output growth accelerated across consumer, intermediate, and investment goods sectors, with the steepest expansion seen in investment goods makers.
- Despite positive trends, sentiment levels among firms slipped to a four-month low, with concerns about inflation weighing down confidence levels.


