Gharials

Context

The state government is pursuing a policy for the reintroduction of the gharial in Orang National Park that became locally extinct more than six decades ago.

* Key Highlights

- Recently, The Assam government had issued a preliminary notification for adding 200.32 sq. km to the 78.82 sq. km Orang National Park.
- Much of the area to be added comprises the Brahmaputra river and the sandbars or islands in it.
- Govt reintroducing the gharial in the area to be added to Orang.

✤ <u>About Gharials</u>

- Gharials (or gavials) are a type of Asian crocodilian distinguished by their long, thin snouts.
- Crocodilians are a group of reptiles that includes crocodiles, alligators, caimans, and more.
- In comparison to Crocodiles, Gharials are very shy and unharmful species.
- India's three species of Crocodilians and their conservation status are as follows :
 - * Gharial:
 - IUCN Red List- Critically Endangered
 - Wild Life (Protection) Act, 1972 Schedule I
 - CITES- Appendix I
 - Mugger crocodile: IUCN- Vulnerable.
 - Saltwater crocodile: IUCN- Least Concern.
 - All the three are listed on Appendix I of CITES and Schedule I of the Wild Life (Protection) Act, 1972.
- However, Saltwater Crocodile populations of Australia, Indonesia and Papua New Guinea are included in Appendix II of CITES.
- Habitats include: Fresh waters of northern India Chambal river, Ghagra, Gandak river and the Sone river (Bihar).
- **Population of Gharials** is a good **indicator** of clean river water.
- Conservation Efforts: Breeding Centres of Kukrail Gharial Rehabilitation Centre in Lucknow, Uttar Pradesh, National Chambal Sanctuary (Gharial Eco Park, Madhya Pradesh).

* About Orang National Park

- Also known as Rajiv Gandhi Orang National Park.
- It is located on the northern bank of the Brahmaputra River
- The Pachnoi river and the Dhansiri rivers flow along the eastern and western boundaries of Orang National Park respectively. Both these rivers are tributaries of the Brahmaputra.
- It was established as a wildlife sanctuary in 1985 but was declared as National Park in 1999. It is also the 49th Tiger Reserve of the country, being notified in 2016.
- Also known as the mini Kaziranga National Park (IUCN site) since the two parks have a similar landscape made up of marshes, streams, and grasslands.
- The park has a rich flora and fauna, including great Indian one-horned rhinoceros, pigmy hog, elephants, wild buffalo and tigers. It is the only stronghold of rhinoceros on the north bank of the Brahmaputra river.
- more than 60% of the Park is under grasses



Protection of Women from Sexual Harassment (POSH) Act, 2013

Context

UUIIUM

Petition has been filed in the Supreme Court challenging guidelines issued by the Bombay High Court in cases under the Protection of Women from Sexual Harassment (POSH) Act, 2013.

Key Highlights

- The provision that challenged pertains to blanket bar on parties and advocates from sharing records, including orders and judgments, with the media.
- The guidelines were formed by Justice G.S. Patel of the Bombay High Court ostensibly to protect the identities of the parties in a case under the POSH Act.

Background of POSH Act

- The SC in a landmark judgement in the Vishakha and others v State of Rajasthan 1997 case gave 'Vishakha guidelines'.
- These guidelines formed the basis for the The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 ("Sexual Harassment Act").

✤ <u>SHE BOX</u>

- Developed By- Ministry of Women and Child Development, Government of India
- It's online complaint management system titled Sexual Harassment electronic–Box (SHe-Box) for registering complaints related to sexual harassment at workplace by women, including government and private employees.

* Mechanism

- The Act defines sexual harassment at the workplace and creates a mechanism for redressal of complaints.
- Every employer is required to constitute an Internal Complaints Committee at each office or branch with 10 or more employees.
- The Complaints Committees have the **powers of civil courts** for gathering evidence.

Penal Provisions

- **Penalties** have been prescribed for employers. Non- compliance with the provisions of the Act shall be punishable with a fine.
- Repeated violations may lead to higher penalties and cancellation of license or registration to conduct business.

Prohibition of use of animals in circus

Context

More than 100 veterinarians across the country have petitioned the Union Minister for Fisheries, Animal Husbandry and Dairying, for notifying rules to prohibit the use of all animals in circuses.

* Key Highlights

- According to PETA, the draft of the **Performing Animals (Registration) Amendment Rules** had been pending since 2018, prolonging the cruelty, pain and suffering endured by circus animals
- The Animal Welfare Board of India, in 2017 and 2019, advised the Central government to pass legislation prohibiting animals in circuses.
- Countries like **Bolivia**, **Bosnia and Herzegovina**, **Cyprus**, **Greece**, **Guatemala**, **Italy**, **and Malta** have prohibited the use of animals in circuses.
- Circuses, are also breeding grounds for zoonotic diseases (those that can jump from other animals to humans), including tuberculosis (found in elephants), glanders (found in horses), parrot fever (found in birds), and Middle East Respiratory Syndrome, which is caused by COVID-19 and can be transmitted to humans from camels.
- Currently, use of bears, monkeys, panthers, tiger and lions, are prohibited but animals like horses, hippos, elephants and dogs are allowed

Animal Welfare Board of India

- It is a statutory body established in 1962 under Section 4 of the Prevention of Cruelty's Act 1960
- Well-known humanitarian **Rukmini Devi Arundale** was instrumental in setting up the board and was its first chair.
- The board grants recognition to Animal Welfare organizations and oversees them
- Under Section 22 of the Act, no person can exhibit or train any performing animal unless he is registered as per rules (Performance Animal Rules 1973) and the Central Government can also prohibit exhibition or training of any animal by notification
 As per the law, circuses performing with animals in India are required to be registered with the Animal Welfare Board of India (AWBI) under the Performing Animal Registration Rules, 2001, as well as with the Central Zoo Authority (CZA) under the Recognition of Zoo Rules, 2009, if performing with exotic animals.



Central Zoo Authority

- Statutory body constituted in 1992 under Wildlife protection Act amended in 1991
- Chaired by Environment Minister
- Recognize and regulates zoos
- Regulates exchange of animals of endangered category listed under Schedule I & II of WPA among zoos.
- Recently, the **Central Zoo Authority cancelled its recognition of the Great Golden Circus** that was using elephants, a protected wildlife species, for performances.

- limit of five approved cash withdrawal transactions per customer per terminal per day.
- Presently, Cash withdrawal from micro ATMs of AePS has a limit of Rs 10,000 per transaction.
- AePS is bank led model which allows online interoperable financial inclusion transaction at PoS through the business correspondent of any bank using the Aadhar authentication
- Business Correspondents are retail agents engaged by banks for providing banking services at locations other than a bank branch/ATM.
- AePS is provided by NPCI. Only inputs required for a customer to do a transaction are: Bank Name, Aadhar Number and Fingerprints.

		 CIS is an arrangement where people pool thier money to invest in an asset, with return and profits shared as per their agreement Collective Investment Management Company (CIMC) are entities that organize, operate and manage a CIS. SEBI intends to empower CIMC to effectively discharge their responsibilities. With no limit on investments, retails investors are primary target of CIS schemes Many companies in India are raising money through agro bonds and plantation bonds in the form of CIS, but not providing adequate protection to investors The objective is to bring them on par with mutual funds by introducing "skin-in-thegame" type regulations like making it mandatory for investing minimum 20% of the salary/perks/bonus etc of the employees of CIMC to be invested in CIS.

Microsoft GitHub	*	 Key Highlights GitHub is the largest open source code repository platform used by developers, startups and even big technology companies to harness the entire coding community's efforts to develop an app. Developers can download the source code for an OS or any app and use it to build their own version. A startup can quickly get codes that would help them add a new feature to their app or service through a code repository Apps downloaded off GitHub are not finished products, and can often have bugs. But unlike social media, GitHub doesn't have filtering algorithms.

Credit Information Companies	*	 <u>Context</u> More entities will become eligible to tap into information with Credit Information Companies (CICs), as the eligibility criteria prescribed by the Reserve Bank of India for entities to be categorized as specified users of CICs.

- A company incorporated in India or a Statutory Corporation established in India, having a net worth of at least ₹2 crore, will be eligible to be categorized as Specified User of Credit Information Companies (CICs)
- Hitherto, specified users included insurance companies; companies providing cellular/phone services; credit rating agencies; brokers registered with SEBI; a trading member registered with a recognised Commodity Exchange; SEBI; and IRDA.
- Currently, there are four CICs Credit Information Bureau (India) Ltd (CIBIL), Equifax Credit Information Services Pvt Ltd, Experian Credit Information Company of India Pvt Ltd and CRIF High Mark Credit Information Services Pvt Ltd. These companies are governed by the Credit Information Companies (Regulation) Act (CICRA) in 2005.
